Submissions will be accepted for the duration of the contest period only. No purchase necessary to enter or win. One entry per person. All entries become the property of CNA and will not be acknowledged or returned. CNA is not responsible for any lost, delayed, incomplete or misdirected entries, nor for any malfunction of the electronic entry form. Entries may be disqualified if they contain information that is incomplete, inaccurate, misleading, vulgar, or if they fail to comply with or attempt to circumvent these Rules.
